

NOTICE OF MEETING

HARRIS COUNTY MUNICIPAL UTILITY DISTRICT NO. 167

The Board of Directors of Harris County Municipal Utility District No. 167 will hold a regular meeting on Wednesday, August 19, 2026, at 6:00 p.m., at the offices of Allen Boone Humphries Robinson LLP, 3200 Southwest Freeway, Suite 2400, Angelina Conference Room, Houston, Texas, to discuss and, if appropriate, act upon the following items:

1. Hear statements and receive questions from the public.
2. Security services matters, including:
 - a. report from Harris County Sheriff's Office; and
 - b. approve Interlocal Agreement for Law Enforcement Services.
3. Security monitoring matters, including:
 - a. security cameras and proposals for same; and
 - b. lighting at District facility sites and proposals for same.
4. Garbage collection and recycling matters.
5. Report on graffiti removal, including proposals for additional work.
6. District website matters.
7. Renewal of District's insurance policies.
8. Approve audit for fiscal year end May 31, 2026.
9. Financial and accounting matters, including payment of the bills and review of investments.
10. Tax assessment and collections matters, including delinquent tax collections report, installment agreements, and payment of tax bills and adopt Resolution Requesting Appraisal of Property and Certificate of Estimated Appraised Value.
11. Discuss 2026 tax rate, set public hearing date, and authorize notice of public hearing regarding adoption of tax rate.
12. Landscaping, park, and recreational facilities maintenance matters, including proposals for additional work.
13. Park and recreational facility matters and projects, including preparation and approval of plans and specifications, advertisement for and review of bids, award of contracts, pay estimates, change orders, and final acceptance, and direct landscape architect to notify insurance company of new facility, if appropriate, for the following:
 - a. Bear Creek trail and sidewalk repair project;
 - b. update on Precinct 4 call for projects;
 - c. review park plan and approve projects for funding with surplus park bond proceeds; and
 - d. striping for Villages of Bear Creek pool parking lot and take appropriate action.
14. Maintenance and permitting of stormwater quality facilities, including:
 - a. proposals for additional work: and

- b. amendment to maintenance schedule.
- 15. Engineering matters, including preparation and approval of plans and specifications, advertisement for bids, bid review, contract award, pay estimates and change orders, acceptance of projects, and direct engineer to notify insurance company of new facility, as appropriate, for the following:
 - a. sanitary sewer rehabilitation project;
 - b. deeds, easements, encroachment agreements, right of entry agreements, and conflicts waiver;
 - c. surface conversion at water plant no. 2;
 - d. inquiries or plans for new development;
 - e. discuss Capital Improvement Plan;
 - f. discuss bond application no. 13; and
 - g. other engineering items, including approve proposal for Phase I ESA for real property acquisition.
- 16. Operation of District facilities, billings, and repairs and maintenance, including the following:
 - a. amend Rate Order, if appropriate; and
 - b. hearing on termination of water and sewer service to delinquent customers and authorize termination of service.
- 17. West Harris County Regional Water Authority matters.
- 18. Minutes of prior Board of Directors meetings, including approval of minutes of July 15, 2026 meeting.
- 19. Convene in Executive Session pursuant to Section 551.072, Texas Government Code, for deliberation regarding real property.
- 20. Reconvene in Open Session and authorize appropriate action regarding real property.
