

NOTICE OF MEETING

HARRIS COUNTY MUNICIPAL UTILITY DISTRICT NO. 167

The Board of Directors of Harris County Municipal Utility District No. 167 will hold a regular meeting on Wednesday, February 18, 2026, at 6:00 p.m., at the offices of Allen Boone Humphries Robinson LLP, 3200 Southwest Freeway, **Suite 2400, Angelina Conference Room**, Houston, Texas, to discuss and, if appropriate, act upon the following items:

1. Hear statements and receive questions from the public.
2. Security services matters, including report from Harris County Sheriff's Office.
3. Security monitoring matters, including:
 - a. security cameras and proposals for same; and
 - b. lighting at District facility sites and proposals for same.
4. Garbage collection and recycling matters, including:
 - a. contract matters; and
 - b. notice of annual CPI increase.
5. Report on graffiti removal, including proposals for additional work.
6. District website matters.
7. Financial and accounting matters, including payment of the bills and review of investments.
8. Discuss Travel Reimbursement Guidelines and Director Expenses for the Association of Water Board Directors winter and summer conferences.
9. Discuss Association of Water Board Directors winter conference, approve reimbursement of eligible expenses, and authorize attendance at summer conference.
10. Adopt Resolution Concerning Exemptions from Taxation.
11. Adopt Resolution Regarding Development Status for 2026 Tax Year.
12. Tax assessment and collections matters, including delinquent tax collections report, installment agreements, and payment of tax bills and adopt Resolution Requesting Appraisal of Property and Certificate of Estimated Appraised Value.
13. Landscaping, park, and recreational facilities maintenance matters, including proposals for additional work.
14. Park and recreational facility matters and projects, including preparation and approval of plans and specifications, advertisement for and review of bids, award of contracts, pay estimates, change orders, and final acceptance, and direct landscape architect to notify insurance company of new facility, if appropriate, for the following:
 - a. Bear Creek trail and sidewalk repair project;
 - b. update on Precinct 4 call for projects; and
 - c. review park plan and approve projects for funding with surplus park bond proceeds.

15. Maintenance and permitting of stormwater quality facilities, including proposals for additional work.
16. Engineering matters, including preparation and approval of plans and specifications, advertisement for bids, bid review, contract award, pay estimates and change orders, acceptance of projects, and direct engineer to notify insurance company of new facility, as appropriate, for the following:
 - a. sanitary sewer rehabilitation project;
 - b. deeds, easements, encroachment agreements, right of entry agreements, and conflicts waiver;
 - c. authorize engineer to design surface conversion at water plant no. 2;
 - d. inquiries or plans for new development;
 - e. update on surplus funds application;
 - f. discuss Capital Improvement Plan;
 - g. discuss bond application no. 13; and
 - h. other engineering items.
17. Operation of District facilities, billings, and repairs and maintenance, including the following:
 - a. amend Rate Order, if appropriate;
 - b. hearing on termination of water and sewer service to delinquent customers and authorize termination of service; and
 - c. approve completion and submittal of Water Usage Reporting Form.
18. West Harris County Regional Water Authority matters.
19. Minutes of prior Board of Directors meetings, including approval of minutes of January 12, 2026, January 14, 2026 and January 21, 2026 meetings.
20. Convene in Executive Session pursuant to Section 551.072, Texas Government Code, for deliberation regarding real property.
21. Reconvene in Open Session and authorize appropriate action regarding real property.
